

**SOMERSET COUNTY PARK COMMISSION
RESOLUTION AWARDING FIRST YEAR OF A TWO-YEAR CONTRACT
FOR GOLF COURSE ACCESSORIES
CONTRACT NO. PCC-0012-18**

WHEREAS, the Director of Finance and Administrative Services and CFO of the Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part of hereof, and such funds are provided for in the temporary budget of the Somerset County Park Commission \$12,000 (31-201-20-851-214-558); and

WHEREAS, the Somerset County Purchasing Office did on January 30, 2018 advertise on the Park Commission website www.somersetcountyparks.org, and on the Somerset County website www.co.somerset.nj.us; and

WHEREAS, three (3) sealed bids were received, opened, and read in public on February 9, 2018 at 2:00 pm prevailing time for Golf Course Accessories, Contract No. PCC-0012-18; and

WHEREAS, the bids were reviewed and it was determined that the bids as submitted by Grass Roots Inc., Fertl-Soil Turf Supply Inc., and SiteOne Landscape Supply meet the requirements of the Park Commission specifications; and

WHEREAS, Grass Roots Inc., Fertl-Soil Turf Supply Inc., and SiteOne Landscape Supply submitted the lowest responsible bids on particular items.

NOW, THEREFORE, BE IT RESOLVED by the Somerset County Park Commission that the bids as submitted by Grass Roots Inc., Fertl-Soil Turf Supply, and SiteOne Landscape Supply be and are hereby accepted as follows:


